

1. Overview of Strategic Direction

Regulatory Impact Analysis is a tool used for the structured exploration of different options to address particular policy issues. It is used where one or more of these options is new regulation or a regulatory change and facilitates the active consideration of alternatives to regulation or lighter forms of regulation. The introduction of a RIA system requires that responsibilities for regulatory development be carefully allocated and ministries engage with the new system.



The process of producing a RIA should be iterative and open to input from public consultation. Commonly it has a simple composition when first set up, and is progressively enriched and adapted as experience is accumulated through the consultation and partial completion of other RIAs.

To become effective, a RIA system should be integrated into the policy process so that the reasoning and the discussion regarding the regulation is supported by empirical information that assists the policy makers in making a decision. Evidence-based decisions increase the likelihood that the proposed regulatory response will achieve policy objectives in the most efficient manner without the imposition of unnecessary or unintended economic costs.

2. T&P's view and approach

In the past several years, T&P has been involved in setting the stage for regulatory development in Macedonia. Thru the development of the legal basis for RIA, as well as the specific Methodology for Regulatory Impact assessment and the Manual for RIA for the civil servants, we have gained focused experience and know-how based on best practices from EU and OECD. Under this strategic objective we will work with public institutions and various stakeholders such as chambers of commerce and NGOs, in the process of regulatory development through organizational development; coaching during the process of Regulatory Impact Assessment (RIA), consultations and establishment of dialog; and support for providing white, blue and green paper.

Based on that experience, we foresee the following initiatives for support of the various stakeholders in the regulatory development process:

For public institutions:

- Assistance in the process of creation of high-quality laws and by-laws. 0
- Assistance in the analysis regarding expected impacts of the proposed regulation ο
- Assistance in setting environment for successful implementation of the process of consultations with stakeholders

For business sector:

- Helping the chambers of commerce to become actively involved in the process of regulatory development through consultations process.
- Improvement of the dialog process between public and private sector in the process of development of laws and by-laws.
- One very important part of the communication between these two sectors is presenting facts and ideas for improvement through blue, green and white paper. Usage of these techniques is known worldwide and has shown transparency in the process of expressing opinions in different topics.

3. Our competences and references

Trajkovski & Partners expertise in the area is based on the long years of experience from different projects. - Pilot project 1: Plan for RIA for Law on court taxes
- Pilot project 2: Plan for RIA, analysis of costs and Initial RIA for Law on waste from packaging.
- Workshop on RIA and the role of business sector in the process
- Presentations on RIA and the process for RIA in all ministries individually

In 2008 T&P consultants were engaged on UNDP project for conducting Desk Review of existing legislation and relevant planning documents concerning Crisis Management System. The objective of the assignment was to conduct an in-depth systematic analysis/review of the existing legislation concerning crisis management and of respective institutional framework of the crisis management system in the country. The focus of the assessment was on the specific competencies, roles, responsibilities and lines of communication and command among each stakeholders participating in the system, in order to identify gaps and "blank spots" and needs for efficient crisis management system.
